## **Twenty two State FFA Associations Receive Grants from CSX**

INDIANAPOLIS (*Tuesday, April 11/National FFA Organization*) – Twenty two state FFA associations and foundations recently received grants from CSX which will help them operate.

The CSX State Grants, which help support a variety of FFA programs and activities, are awarded to associations and foundations located in the 22 states where CSX currently operates. States currently receiving funding include: Alabama, Connecticut, Delaware, Georgia, Florida, Illinois, Indiana, Kentucky, Louisiana, Maryland, Massachusetts, Michigan, Mississippi, North Carolina, New Jersey, Ohio, Pennsylvania, South Carolina, Tennessee, Virginia and West Virginia.

The grants, which have been awarded since 2012, can be used by the state foundation and associations in such a way as to assist with FFA programming and support. For example, some states have used the funds for workshops, conferences and state conventions, while others have used the fund to update facilities used for FFA events. The grants offer states flexibility to use where it will be most impactful for the members they serve.

“In addition to the program support provided to the FFA Foundation, CSX recognizes that state FFA organizations have their own priorities which can benefit from these grants”, said Tori Kaplan, Vice President, Communications and Field Support. “The funding provides the flexibility for state organizations to operate more effectively and often helps make connections with CSX and its employees locally. Building relationships with FFA at the state level are equally important to the valued relationship we enjoy with the National FFA Organization.”
